Over 13 years of experience in QA/Software Testing functions, acting as a key player leading the QA team in e-commerce & Fin-tech companies such as Amazon, Al Tayer, level shoes & Payfuture. Expertise in Full system development life cycle, including designing, developing & implementing test plans, test cases and test processes fueling swift corrective actions. Hands-on technology professional accustomed to working in complex, competitive and project-based environments. Skilled in analysis, decision-making, and leadership, with the ability to achieve goals effectively. Ability to interact easily with people of diverse backgrounds, cultures and professional levels.

CAREER HIGHLIGHTS

- I led a critical project called warehouse stock consolidation aimed at boosting sales on <https://www.ounass.ae/>. My test strategy thoroughly covered backend, frontend, and all workflow components including Magento, inventory management, retail management, warehouse management, and 3PL systems. I ensured seamless testing of both user and system workflows, ensuring this change doesn't break the flow of the other brands which share some of the common workflows.
- The automation roadmap aimed to automate all test cases using a UI tool initially but faced challenges such as extended test durations (2 hours for 30 tests) and maintainability issues with the code. I proposed shifting to API testing with Postman for 100% automation, with UI testing limited to basic user workflows. This approach was approved by the business and successfully improved test case coverage. This initiative marked my first step in streamlining QA activities at Al Tayer
- I introduced a proactive approach to enhance build quality within the team. Due to project deadlines and other factors, developers were unable to prioritize unit testing, making it challenging to maintain high-quality builds and reduce the build cycle. To address this issue, I incorporated QA priority test cases into the pipeline and configured Jenkins so that these tests would automatically run upon every merge to the master branch. This ensured that the success of each build was contingent upon passing these critical tests, significantly improving overall build quality and reliability.
- In a desktop application I worked on, supporting multiple platforms with various versions led to extensive manual testing for new features, resulting in prolonged testing timelines. To address this challenge, I implemented parallel/Staggered test case execution across multiple platforms simultaneously. This involved reading a test case once and executing it on at least two platforms concurrently. Infrastructure adjustments were also implemented to support and facilitate this streamlined testing approach. Also, created custom automation support to record and replay the user action on top of Desktop application which led to the Manual execution from 10 days to 2 days with the automation & eliminated the 4 manual resource
- Due to instability in the Level shoes production environment, infrastructure changes have become necessary. These changes significantly affected the entire system, with a primary focus on enhancing stability and durability. Demonstrating the effectiveness of the new infrastructure posed considerable challenges. To address this, I introduced a new load testing tool called "Loadster," which enabled us to measure and compare the performance and stability of both the new and existing infrastructures.
